### From the President's Pen John Jastrzembski

#### Same Battle - Different Fronts

I have been President of MFA for three months now. It has been exciting and fun! Some of the major events I (MFA) participated in include formulation of the MFA Forestry Jobs Initiative, development of four MFA Policy Statements, attending the Governor's Forum on Sustainability, and testifying against the sale of 4,000 forested acres of the Cumberland City Watershed. I was also involved in many meetings: phone meetings, dinner meetings, and a few meetings in the woods.

MFA's Logis lative Notabook is at the printers as I write this and I think our members will be happy with this document. The MFA Forestry Jobs Initiative is available on MFA's blog. You may have read about it in your local paper as a press release was distributed throughout Maryland/DC. I would like to take this opportunity to thank the many people that came together to help us develop this document: Bill Miles (Association of Forest Industries), Gary Allen (Sustainable Forestry Council), Pat More (NewPage Corp.), Steve Koehn (DNR- Forest Service), Steve Castrogiovanni (Maryland Arborist Association), Craig Highfield (Chesapeake Bay Foundation), Tom Wieland (Glatfelter Corp), Jim Bardsley (Forest Conservancy District Boards) and Chris Holmgren (Forest Products Operator). All these people and the groups they represent ARE our allies and colleagues. We are fighting the same battle but we are fighting on different fronts!

I am very pleased that MFA has developed four policy statements which were released in unison with the 2011 Legislative Session. These four policy statements are abridged white papers. They include MFA positions on: Family Forest Ownership, Diversifying Local Economies including the issue of LEED Certification, Bio-Energy, and Bio-Threats. These policy statements can be found in the beginning of our Legislative Notebook. We asked for input from other forestry organizations on these Policy Statements. These 'sister organizations' helped to strengthen this document. Remember same battle —different front!

I found the **Governor's Forum on Sustainability** quite refreshing. The Forum exhibited that most of the 600+/- people in attendance caned about the sustainability of Maryland and Maryland's forest resources. These people may not know a darn thing about forest management, private holdings or the importance of Maryland's 47 billion forest economy, but they know that forests and trees are important for the health of the Bay. We are all in the same battle but on different fronts!

Not everything is great though. I must draw attention to a major issue affecting family forest landowners. Essentially, the US Green Building Council (LGGBC) certifies "Green Buildings". There are major problems with how this federally endorsed "environmental building certification program" treats forestry. There are more complexities than can be presented here. However, know that the USGBC is anti-family forests and anti-family forest landowners. They have shut Tree Farmers @ and Stewardship forest out of their business model. The USGBC only permit the use of FSC Certified CONTINUED ON PAGE 7

# DNR Signs Groundbreaking Memorandum Of Understanding Dedicated To Healthy, Keeping Productive Forests

Annapolis, Md. (January 24, 2011) — The Maryland Department of Natural Resources (DNR) has signed a groundbreaking Memorandum of Understanding with six other federal and state agencies dedicated to keeping healthy and productive forests throughout the State.

By improving how our partners hips function, and improving how we plan the delivery of our respective programs, we anticipate the forest landowner will get better service and working landscapes will benefit. said Steve Kochn. State Forester for DNK. Better forest management results in more benefits for all Marylanders: healthy forests boost local economies, clean our air, filter our water, regulate temperatures, provide habitat for wildlife and provide pleasant green-scapes for our everyday activities.

The other partnering agencies include: the Maryland Association of Forest Conservancy District Boards; the Maryland Association of Soil Conservation Districts; the Maryland Department of Agriculture; the University of Maryland Extension; and the United States Departments of Agriculture - Forest Service and Natural Resources Conservation Service (NRCS).

Under this agreement, the agencies will work together to be more effective in providing forest owners and managers with technical and financial assistance to improve the health, diversity and production of forests on privately owned lands — 76 percent of all forests in Maryland.

The Maryland NRCS boke forward to working closely with the Maryland Forest Service and the rest of the cooperating agencies to advance healthy working forests that improve water quality in the Chesapeake Bay while helping to build rural wealth. said Jon Hall, State Conservationist for the local NRCS office.

The memorandum identifies four areas to focus immediate attention, including addressing the shortage of technical experts available to meet the demands from the 187,000 private forest owners in Maryland; integrating programming between the agencies to make it easy for forest owners to participate in technical and financial assistance programs; demonstrating that funding on-the-ground forestry and agroforestry projects is a good investment in our future economy and environment; and cross-training the staffs of the respective organizations.

Each of the signatories brings unique and complementary roles to the partnership:

- DNK's Forest Service has the primary leaders hip to be for all forestry programs in the State.
- The Maryland Association of Forest Conservancy District Boards assists the Forest Service with the promotion of rural forest management and helps assure a supply of wood fiber products through scientific forest management.
- Soil Conservation Districts carry out natural resource management at the local level and are recognized as the delivery system
  for soil conservation and water quality programs, often acting as a liaison between private landowners and government
  assistance programs.
- The Maryland Department of Agriculture provides leadership and support regarding agriculture to the citizens of Maryland by conducting regulatory, technical and financial assistance programs, and educational activities that assure consumer confidence, protect the environment, improve conservation and natural resource management and promote agriculture.
- The University of Maryland Extension provides primary leadership in forestry related educational programs, outreach, and applied
  research and demonstrations for both private landowners and professional natural resource managers. They also provide
  research and educational support related to conservation and natural resource management on all working lands including
  agricultural lands.
- The US Forest Service, Northeastern Area State and Private Forestry, works cooperatively with other federal, state, local governments; institutions of higher learning; and profit and non-profit organizations to provide forestry leadership, and financial and technical assistance.
- NRCS works in partnership with America's private land owners and managers to conserve and sustain soil, water, and other natural resources.

## Maryland Forests Association Initiative Promotes Forestry-based Jobs The Maryland Forests Association (MFA), Maryland's premier forest advocacy membership

group, is encouraging state run agencies, other forest advocacy groups, trade associations and the forest products industry to work together to promote economically viable and sustainable forest management.

Managing our trees and forests create jobs and helps makes our state sustainable. This initiative is designed to increase the forest economic impact in Maryland. "We have a green and renewable resource if it is nurtured and cared for ecientifically, stated John Jastrzembski, President of the MFA and Professor of Forestry at Allegany College of Maryland. "Sustainable forests are healthy, vibrant, improve quality of life, and create jobs. All Marylanders benefit from healthy, well managed forests. This is evident with Marylands Sustainable Forestry Act of 2009, the most comprehensive state forestry legislation in the nation." exclaimed Jastrzembski.

William R. Miles, speaking on behalf of the Association of Forest Industries, stated "The nationally-acclaimed Sustainable Forestry Act of 2009 sets forth statutory strategies intended to promote the retention of privately-owned forest land because of their measurable environmental and economic contributions to the Chesapeake Bay restoration effort and rural resource-based communities. In short, this historic Act — a model for national emulation -- makes clear that forestry is the preferred land use within the State of Maryland and that every reasonable policy-related effort 6 hould be advanced to promote forest land retention."

There are many insects and diseases that are wrecking havoc on Maryland's forest ecology and economy.

The New Page Luke mill is Maryland's largest forest products company and has a long history of conservation of natural resources, having been established in Allegany County in 1888. stated Pat Moore, Luke Mill Manager. Our operation currently employs approximately 950 individuals, produces 1,500 tons per day of coated paper, and uses approximately 4,000 tons of wood per day as a raw material. Responsible forest management is critical to ensuring an adequate supply of wood fiber for our papermaking operation, and we applaud Maryland for the great work that they are doing in this area.

Glatfelter is another large employer in the state and primarily situated on Maryland's Eastern Shore. Tom Wieland, Regional Forest Manager of Glatfelter noted that the recession may be technically over but signs that our forest products suppliers and family forest landowners are struggling.

\*\*Our Foreste are strategically important.\*.commented State Forester Steve Koehn, who spearheads forestry issues for the Maryland Department of Natural Resources and is the past president of the National Association of State Foresters. \*\*Our state forests, family owned forests, and industrial partners provide a myriad of benefits for Marylanders. Our forests are important for improving air and water quality, storing carbon, improving quality of life, enhancing wildlife habitat and providing sustainable jobs\*\*

"We want people to understand that forest management includes using forests in a sustainable fashion", said Chris Holmgren, a forest products operator located in Montgomery County. "I by working in the woods and utilizing trees that in many cases are destined for a landfill. I create furniture and other products from these waste materials. It drives me crazy that people think I am destroying forest. I am a conservationist. I represent a portion of Marylands green industry. I am a small business owner. I am proud to promote sustainable forest management in Maryland."

Maintaining Maryland's forests is crucial in protecting wildlife habitat and imperative in improving the quality of our streams, rivers and the Chesapeake Bay. "Supporting a vibrant and sustainable forest based economy is an important way to ensure that our forests remain forests by affording landowners a sustainable revenue opportunity as an alternative to development. Growing green forest based jobs can be good for both Maryland's natural resources and its local economies." exclaimed Craig Highfield, coordinator of the Alliance for the Chesapeake Bay's Forestry for the Bay program.

"The Maryland Association of Forest Conservancy District Boards, with "Forestry Boards" in every county encourages local jurisdictions to manage their forested resources wisely. We are losing approximately 7,000 acres of forest annually in Maryland. This simply is not sustainable and we are working at the county level to help conserve Marylands forests and educate the public about how individuals can help and the many benefits of preserving trees," added Jim Bardsley, Association President, biologist, and Anne Arundel County resident.

"Our forests are critical to Maryland's future and the restoration of the Chesapeaks Bay, not just ecologically but economically too". Said Gary G. Allen, Chairman of the new Sustainable Forestry Council created by the 2009 Act and appointed by the Governor O'Malley to define and lead the effort to sustain Maryland's forest lands into the 21st Century. Sustainable management of our forest resources will produce sustainable jobs." Allen emphasized.

In Maryland, the forest products industry and associated green industries including arborculture, urban design, and nursery management produce 37,000 jobs. Managed forest can create more jobs. "Nurturing our forests and trees nurtures jobs" said Steve Castrogiovanni, President of the Maryland Arborist Association. "a green Maryland benefits everyone."

"Maryland's forest industry contributes \$7 billion in economic output with 37,000 jobs. There are 130,000 family owned forests in Maryland," states Karin Miller, Executive Director of the Maryland Forests Association. "MFA works to insure that vibrant forests are maintained throughout the State, providing diverse economic and environmental benefits to all Marylanders."

MARYLAND STATE FORESTER ELECTED TO SFI INC. BOARD ~ Maryland State Forester Steven W. Koehn was recently sected to the independent Sustainable Forestry Initiative Inc. (SFI®) Board of Directors. Koehn is past president of the National Association of State Foresters, which passed a policy statement in 2008 stating that all forest certification programs make positive contributions to forest sustainability. Koehn is particularly interested in working with the U.S. Green Building Council to open up its LEED certified wood credit to all certification programs. "Limiting the forest certification credit, as the LEED rating tool currently does, denies credit to the vast majority of domestic well-managed forests and certified forests," he said. "This is not good for our forests or our communities." Koehn has been director and state forester with the Maryland Department of Natural Resources, Forest Service, for almost 10 years. He played a vital leadership role in the passage of the Maryland Sustainable Forestry Act of 2009, which recognizes that an important way to improve the health of Maryland's vast Chesapeake Bay ecosystem is through healthy forests.

#### **GEOCACHING MARYLAND'S BIG TREES**

Geocaching, a type of high-tech treasure hunt, is a rapidly growing outdoor activity in which geocachers hide containers of various sorts at locations recorded by GPS coordinates. The location of the container as well as information

about its contents and its significance are then uploaded to a website where other geo-cachers can download it to their GPS unite and begin the 'hunt'. To promote the Allegany County and Maryland Big Tree Programs, Green Ridge State Forest (GRSF) is developing geocache sites at each of the county and state champion big trees located within GRSF boundaries. The big tree cache series currently consists of 3 champion trees located within GRSF (pignut hickory, cucumbertree, and white ash). Each cache contains a card describing identifying characteristics of its tree, historical and/or commercial values of the species, and information pertinent to the specific big tree. Those who find the cache sign the log book in the container and also log their find on the website. The geocaching program at Green Ridge has seen tremendous feedback in the few short months it has existed, and is expected to grow through spring and summer and as new caches are placed at other big trees. wood in their certification process. They do not recognize Tree Farm @ or S FI (Sustainable Forestry Initiative) certification programs. The USGBC (and the Maryland Green Building Council) force the "green-building" industry to purchase trees from other states and primarily from developing countries rather than our home grown, Maryland certified wood. This is unacceptable. Maryland's family forest landowners should not tolerate this bureaucratic absurdity. The consequences are monumental: sale of family forest land for development; foreclosure of forest products operator; increase import of wood products from other countries; loss of manufacturing jobs in Maryland. It is critical that family forest landowners and the wood products industry fight this battle in unison. Governors from over 15 states are calling for revisions to the Green Building Council certification structure and accounting principles. We are working with other groups to make changes to USGBC current recognition of LEEDonly Certification, Again, same battle - different front.

I also must let you know that the many other groups with a more National perspective have been looking out for your interest too. Groups including the Forest Landowner's Association, the American Forests Foundation, and the National Woodland Owners Association have succeeded in minimizing the Federal Capital Gains Estate Transfer tax. Interestingly, this did not even make most of the media outlets. The President's Tax Bill would have had disastrous impact on the estates of forest landowners. Fortunately, others were fighting this battle for us. - Different fronts! Because of the importance of a national perspective, MFA is considering affiliation with National Woodland Owners Association. Read more about that in the draft NWOA-MOU that can be viewed online. We are also working to create a closer relationship with Maryland Tree Farm.

MFA is only as strong as its membership. Now I ask you to take action in the same battle but on a different front- your front! Please help:

Download a copy of our Legislative Notebook Read it, and email it to your Maryland Legislators and ask them to support forestry in Maryland. Also, email it to five friends encouraging them to join MFA.

Download a copy of MFA's Forestry Jobs Initiative. Read it, email it to your Maryland Legislators and ask them to support forestry in Maryland. Also, email it to you local newspaper or radio station. (seen also in part on page 5 of this publication)

Review our Policy Statement on LEED Certification. Send the Governor an email asking him to work to change LEED Certification requirements for the protection of Maryland's Family Forests.
